Bulk Trash

Bulk trash pickup is every second Monday of the month. Please do not put out items before SATURDAY AFTERNOON, and no later than MONDAY 5am. It is not unusual that after the bulk items are picked up, there is some debris left. This is especially prevalent with landscape refuse. The street sweeper schedule does not coincide with our bulk trash pick- up, so please do your part to keep our streets nice and clear of any debris.

Pool Backwashing

Do not drain water into the common areas, street, alleyway or other City of Avondale right of way. If you have to drain out your pool completely your best option is to put it down the home's sewer clean-out. The clean-out is usually located next to the house at the point closest to the city sewer line and usually outside a bathroom or the kitchen. Per City of Avondale Municipal Code 8-56, it shall be a civil (non-criminal) violation, punishable with a civil penalty up to \$2500 per day, for a person to use, handle, store, treat, spill, dump, or dispose of stormwater, pollutants or significant materials in a manner that creates a public nuisance as defined in Section 8-47.

Stagnant Water

It has been brought to our attention that many homeowners are experiencing issues with mosquitoes in the neighborhood due to stagnant water left from rains, overwatering, green pools, etc. Stagnant water increases mosquito activity. Please be sure you are doing your part and ensuring your property does not have any potential breeding areas and please report green pools to Maricopa County Vector Control at 602-506-6616 or use the online complaint form www.maricopa.gov/EnvSvc.
