Upcoming Street Parking Vote - Make Your Voice Heard

In February, homeowners will have the opportunity to decide on whether our HOA will retain its authority over public street parking within our community. This important decision will help shape how our neighborhood is managed in the future. In the next week. Online voting details, along with meeting information, will be available on our website:

Why Are We Voting?

In April, Arizona passed House Bill 2298, which prohibits HOAs from regulating parking on public streets if their rules were established in 2015 or later. However, communities with parking rules predating December 31, 2014—like ours—are allowed to vote to retain these rules. This vote will determine whether the HOA continues enforcing street parking regulations outlined in our Covenants, Conditions, and Restrictions (CC&Rs).

Voting Details

You have multiple ways to cast your vote. Please note: One vote per household and only homeowners may participate.

- 1. Online Voting: You will receive voting instructions by mail. In the instructions will be your individual voting code. Once you have your voting code, visit https://wearevision.com/evoting/bwr to vote.
- 2. In-Person Voting: Votes can be cast during the online meeting on February 25, 2025, from 6:30 p.m. to 6:45 p.m. Meeting details are available at wearevision.com/bwr.
- 3. Absentee Ballot: If you cannot vote online or in person, request a mail-in ballot from Vision Community Management (contact details below). Completed ballots must be received by February 24, 2025, at 12:00 p.m.

Vote Counting and Results: All votes will be counted during the meeting on February 25, 2025, starting at 6:45 p.m., with results announced shortly after.

What's Needed for the Vote to Count?

For the vote to be valid:

- At least 10% of homeowners must participate to establish quorum.
- A majority of participating homeowners must vote in favor of retaining the HOA's authority.
- If the vote passes, the HOA will maintain its authority to enforce street parking regulations as outlined in the CC&Rs.
- If quorum is not met or the vote does not pass by June 30, 2025, the HOA will lose its authority over public street parking, and enforcement will permanently transfer to the City of Surprise.

What Are Your Options?

1. Voting to Continue HOA Regulation

The HOA will retain its authority to enforce parking and roadway rules as outlined in the CC&Rs, including:

- · Restrictions on parking motor homes, trailers, and commercial vehicles.
- · Rules governing the temporary placement of basketball hoops, garbage containers, and other items in the streets.
- This option may appeal to homeowners who value consistent neighborhood appearance and HOA management of parking concerns.

2. Voting Against HOA Regulation

The HOA will no longer have the authority to enforce parking and roadway rules as outlined in the CC&Rs which means:

- Regulation of public streets will transfer to the jurisdiction of city ordinances and the Surprise Police Department.
- Homeowners will rely on city resources to address issues such as illegally parked vehicles or blocked roadways.
- · This option may appeal to homeowners seeking greater flexibility in parking and street use near their homes.

Important Note: Under current law, this decision cannot be revisited in the future, so it's crucial to carefully consider your vote.
