<u>OPEN MEETING LAW</u>: Association meetings are required to comply with <u>A.R.S. 33-1804</u>, commonly referred to as the **Open Meeting Law for Planned Communities**. Meetings are open to all Members wishing to attend. However, there are circumstances where the Board may elect to meet in a closed meeting or "executive session".

EXECUTIVE SESSION: The Board will meet in a closed executive session before each scheduled board meeting. Discussion is limited to consideration of one or more of the following:

- (1) Legal advice from an attorney for the board or the association.
- (2) Pending or contemplated litigation.
- (3) Personal, health, or financial information about an individual member of the association.
- (4) An individual employee of the association or an individual employee of a contractor for the association.
- (5) Matters relating to the job performance of, compensation of, health records of or specific complaints against an individual employee of the association or an individual employee of a contractor of the association.
- (6) A member's appeal of any violation cited or penalty imposed, except on the request of the affected member that the meeting be held in an open session.

NOTICE TO PARENTS: Any open meeting of the Association may be recorded by those attending. Recordings may be posted on the Association's Members-only webportal. If you permit your child to participate in one of our meetings, please assume a recording will be made. If your child is seated in the audience, your child may be recorded, but you may request that your child be seated in a designated area to avoid recording. Please submit your request prior to the start of the meeting.
