Trash pick-up: Monday & Thursday mornings between 2:00a-4:00a. Do not place your trash at the curb of the building you reside in until at least 6:00p the night before. There is a dumpster you can use at any time in Lot C. However – the *dumpster is not for bulk trash. Break down boxes* before using the dumpster. Don't place trash on ground next to it.

Recycle pick-up: Wednesday mornings between 2:00a-4:00a. Recyclable items include: cardboard, paper, plastic, glass and small cans. All containers must be washed out and clean before putting in the recycle bin. Unclean containers contaminate and leak, destroying any chance that anything in the bin can be recycled. *Also, do not bag your recyclables. If recyclables are bagged, the recycling company throws it in with garbage.

Pet Friendly Community: We love our pets! Please remember to keep dogs on leash. Use bags to pick up your pet's waste, and place in trash container. We have two locations for free waste bags, Belmont Ave & Frier – at the green space. The second is on Dreamy Draw Drive.

Pool area: No smoking in the pool area, no glass in the pool area and no pets in the pool area.

ASSOCIATION NEWSLETTER

A CAMPAIGN TO IMPROVE AND UPDATE OUR COMMUNITY

The Pointe Community Association is in the process of waging a campaign to gather the votes necessary to lower the number of homeowner votes required to change our current HBA rules. Currently, 7/8 of all homeowners must register a "Yes" vote to change our current HBA's. The Association seeks to lower that number to 66% or 2/3 of all homeowners input.

WHY CHANGE?

- It is virtually impossible to achieve 7/8ths participation in vote of community members, making change also nearly impossible.
- The HBAs were written 40 years ago. Over time, the HBA's have become unworkable, outdated and virtually unenforceable. They no longer fit our community needs and practices.

For example: Outdated rules in the HBA's include:

- Xeriscaping or landscaping your yard to reduce or eliminate the need for irrigation is prohibited in your yards
- Working from home is not permitted by our current HBAs.

HOW YOU CAN HELP:

 Reach out to your neighbors, full-time and part-time residents, to explain the importance of this vote and then, VOTE!

Wash Cleanup – Maintenance or Removal?

Last month's Board meeting resulted in a decision to table the vote on expanding the scope of this year's "wash clean up" in order to:

- Solicit input from homeowners who are directly affected by tree removal and live adjacent to the arroyo.
- Solicit additional subject matter expertise (arborist's perspective) on the invasive African Sumac problem.

Background: The Clean Water Act requires that water flows freely through our arroyo (aka Dreamy Draw). To date, we have managed the population of the invasive African sumac trees incrementally to avoid obstructing the flow of water and associated penalties. This year, the Board is considering an option to remove ALL African sumac trees in the entire wash rather than continue its regular staged wash maintenance schedule and elimination of new growth. Options will be revisited by the Pointe Community Board of Directors (with the support of the Common Area Committee) after the HBA Update initiative is completed. Stay tuned.


