

Do's and Don'ts

The following photographs are offered to provide clarification on what and what's not acceptable when painting your home.

The Santa Fe Ridge HOA provides one of the most extensive paint color choices available of any HOA in the valley.

We have provided this to insure conformability in our Community but also allow individuality of the Homeowner.



Do — The eve should be completely painted to match the Trim Color.



Don't — Painting only the Trim Face is unacceptable.



Do — Here is a beautiful example of scheme 12. Note the bump outs are painted on all three sides.



Don't — The homeowner used three colors in place of the allowed two colors referenced in the CC&R code indicating only Two.



Do — Here is another example using the approved two color scheme. Bump outs are to be painted on all three sides.



Don't — Not following the approved color schemes, this home owner used four colors in place of the the standard two.



Don't — Following HOA painting guide lines, the garage door must be painted to match main body color.



Don't — The garage door and trim are scheme 12, However the Homeowner added a third main body color.



Don't — Bump outs must be painted on all three sides, not just the front as shown above.



Don't — Louvers must be painted the same as the Main Body color or the Trim color.



Don't — Gates may be painted either the same as the Main Body, Trim Color, or Natural wood. Natural Wood Gates must be sealed.



Don't — The porch supports Must be painted to match the trim of the house..

Exterior Paint, Roofing, Bump-Outs & Block Walls

Any changes to or replacement of roofing must be submitted to the Architectural Review Committee for approval. In general, the color of roofing should compliment the exterior color scheme of the house.

1. Exterior Paint — Gloss paint may not be used on either the base or trim of your home. Flat paint should be used on the base of the house and either flat or satin should be used for the trim. Gloss paint is allowed on entry doors. Natural wood entry doors need not be painted, but should be stained and sealed.

Note: Garage Doors and Side Doors must be painted the same color as the house base paint or trim color. Front Entry Doors must be painted to match the House Trim Color.

2. **Drip Edge** — Must be White, Brown, or painted the same as the trim color to maintain the overall appearance of the house.

Note: At no time may the Drip Edge remain unfinished or left in bare metal condition.

3. Roof Jacks & Vents —

Must be painted White, Gray, Brown, or the same as the house trim color. Whichever is most complimentary to the roof and overall appearance of the property.

Exterior Paint, Roofing, Bump-Outs & Block Walls

3. Roof Jacks & Vents continued —

Note: Any roofing contractor signage must be removed from the property upon completion of the roofing work.

4. Bump-Outs — May be painted to match the homes "base" or "trim" colors only. A third accent color is not allowed.

Note: All three sides of the Bump-Outs must be painted.

5. Block Walls — Block Walls where significant degradation and discoloration have occurred to the wall, it is Recommended using Dunn-Edwards Custom Color located on page 21.

For general painting of Block Walls use DE6124.



Note: Stucco Covered Block Walls must be painted to match the homes "Base" color only.

A third Accent Color is not allowed.
