Arizona Consolidated Services, LLC and Arizona Submetering Solutions would like to introduce ourselves as your water utility billing company.

Your first bill for water usage and services will be November 16, 2017. Meters will be read monthly, and bills will be sent out within five days of the reading. You will be billed for your actual water usage, base fees and waste water, at the same rate that your HOA pays to the city. You will not be billed for "common water" i.e. water used for landscaping, pools, fountains, etc. In addition, there is a monthly charge for our service.

Water bills are considered timely if paid within 21 days of the billing date. Water disconnects are conducted for *non-payment* of water bills when 51 days past due. We offer a variety of payment methods. You can mail in your payment, pay online, come into our office or pay by phone. Please be aware that there are fees associated for online or credit/debit card payments.

All administration of the sub meter system will be administered by Arizona Sub Metering Solutions and all water related questions should be directed to us.
