Exterior Walls: Navajo White (Dunn Edwards) or (Behr) Navajo White 22u W3-5, Linen White 70u W3-4, Cottage White 13u W3-3, White Veil OR-W14u W3-2.

Garage Doors: Navajo White (Dunn Edwards) if the home is painted with Dunn Edwards Navajo White. Painting the home with a Behr Paint Color then the garage door shall be the same color. ***See Pointe Rules for SFA/SFD design.***

Trim: Behr Paint Colors (stated above) If the home is painted with a Behr paint color, trim can be the same. Using Dunn Edwards Navajo White Paint, trim can be the same color. Norfolk Brown (Dunn Edwards) can be used as trim for any of the paint colors chosen.

Wrought Iron: Behr Colors, Navajo white or black

Window Frames: Navajo White/Behr Colors or Anodized Brown

Awnings: Terracotta Forrest Green True Brown Royal Navy  
(SKU 4622-000) (SKU 4637-000) (SKU 4621-000) (SKU 2079-0060)

Walls: Navajo White (Dunn Edwards) use this for walls if home painted with Dunn Edwards Navajo White. If painting home with a Behr Paint Color the walls shall be painted the same color. ***\*HBA height with no decorative block.***
