### **Claims**

- If you need to file a claim, call your personal insurance agent first. After opening your own claim, if you feel that the association needs to also file a claim on the master policy, notify Vision Property Management immediately at **480-759-4945**.

### **Purchasing your individual policy:**

- If your personal policy is with American Family, and there is a claim involving both policies, your personal deductible will be waived.
